#### **2. Minutes of the last AGM (17 October 2016)**

#### **4. Chair's report**

The chair, Bill Wolstencroft, gave his report to the meeting. The club began the year with uncertainty. Everybody Sport and Recreation (ESAR), the provider of the leisure centre, were saying that they wanted to take all lessons in-house.

Using contacts with the MP for Congleton, and others, the chair had a meeting with Kris Sankey, ESAR Aquatics Manager and Cllr Andrew Kolker, chair of ESAR. They thought our club deserved special consideration because



it is entirely volunteer-run and led and is not competitive. They agreed to change the arrangement, so that the club is now permitted to encourage children to be safe in water and to enjoy swimming in a social and participatory environment.

The club kept prices the same, which has meant dipping into reserves, but the club continues.

The chair and secretary, after four and a half years in role, want to stand down. With the club potentially not being able to replace the two officers, the chair and secretary went to see ESAR and explained the club was running out of leadership and they agreed to work with the club. The result of the elections below show that this proved not to be necessary.

It was with great sadness that the club learned of the death of Peter Axson. Peter, with a group of friends, had taken over the running of the club in 1974 and continued until recently, when the current officers took over. It is without doubt that the existence of the club is down to Peter and there is a huge number of people who learned to swim, with his guidance including parents of current members.

### **5. Treasurer's report**

The treasurer presented the accounts which show a reduction in reserves of £800 since the 2015-16, now being at £8,600. Over the coming months, the financial situation needs to be carefully monitored. If the reserves start to go down there may need to be a revision in pricing or the club will need to look to raising money elsewhere.
